

Sealed tenders are invited from those experienced contractors who are registered with Federal and Provincial Tax authorities having a minimum experience of 10 years for "hiring the services of photocopier at PRC Towers Karachi" as per the requirement:-

Specific Terms and Conditions:-

- The contractor shall deploy highly trained person (s) to operate photocopy machines.
- The contractor will be responsible for the maintenance and satisfactory operation of the photocopier machines installed by him at PRC Towers, Karachi.
- The contractor will be responsible for providing un-interrupted photocopy at PRC Towers, Karachi as per requirement.
- The contractor will make the photocopies against duly approved requisition submitted by the concerned department.
- The contractor will provide multipurpose copier performing job of photocopies with back up copier, whole maintenance such as toner, drum, developer and other parts.
- The contractor will provide good quality paper between 70-80 Grams as required from time to time.
- The contractor will provide the services during regular business hours of the PRCL i.e. Monday to Friday (except holidays) from 08:30 a.m. to 05:30 p.m. and as and when required by PRCL.
- PRCL will only pay photocopies charges to the contractor.
- Rates shall be quoted after giving due consideration to the space and electricity provided by PRCL
- The contract period for photocopies will be for two year from the date of signing of agreement.
- PRCL will settle the contractor bill on monthly basis after deduction of applicable government taxes.
- PRCL will hold the amount of 2% Earnest Money (refundable) of the quoted amount which will be submitted in the shape of Pay Order in favor of Pakistan Reinsurance Company Limited, Karachi accompanied with the bid.

General Conditions:-

- ❖ The Earnest Money of unsuccessful bidders will be returned to them after the award of work to the successful bidder.
- ❖ The amount of Earnest Money will be released to the successful bidder after the completion of the contract period.
- ❖ The tender notice is only to invite the tender and Pakistan Reinsurance Company Limited is not bound to accept the lowest bid or any other tender and reserves the right to accept or reject any tender as per PPRA Rules.
- Complete set of tender documents/terms and conditions must be returned along with the bid.
- ❖ The price/rate shall be quoted in Pak Rupees including all applicable taxes.
- PRCL does not allow to assign sublet/subcontract the whole work or any part thereof or any benefit or interest therein or there-under.
- The bidder must attach authenticated list of clients served during the last five years list of clients, presently being served, list of tools and equipments owned, list of material used & techniques adopted.
- ❖ In the case of any damage and injury to the contractor's staff, PRCL will not be responsible at all.
- ❖ PRCL shall have the right to terminate the Contract wholly or partly by giving a notice of 30 days to the Contractor and to invoke/forfeit the earnest money submitted by the Contract.
- ❖ The Contractor shall have right to terminate the contract by giving a notice period of at least 30 days.
- ❖ Bids in detail will be submitted on respective letterhead.
- ❖ The bidders shall provide the Name of the Bank, Account Number, List of Clients, List of Machines and equipments, list of materials used, along with the bid. Copies of the registration with tax authorities must be attached with the bid.
- ❖ In the case of any dispute occurs the CEO of PRCL or his nominee will be the final authority to decide and his decision will be final and accepted by the both parties.
- ❖ The sealed stamped quotations addressed to the Incharge (Admin), PRCL, Karachi should be dropped in the tender box placed at 14th floor, PRC Towers, MT Khan Road, Karachi on the date and time mentioned above.
- ❖ The Contact comprises the execution and performance of the work and insofar as not otherwise specified in the Contact, provision of all labor, consumable materials, equipment, tools and plant. Temporary work and everything whether of a permanent or temporary nature required in and for such execution, supervision and management, so far as the necessity for providing the same is specified in the contract or is to be reasonably inferred from the Contract.
- ❖ PRCL will sign the contact with the successful bidder.
- ❖ The commencement date of work will be determined by the employer's representative considering the actual date of commencement of total works by the contractor as defined in the scope of work.

- ❖ In no case of Contractor will delay the start of work beyond 15 days from the date of issuance of agreement.
- ❖ If the standard of services of photocopies provided by the Contractor is not up to the standard acceptable to the Employer's Representative, then the Employer's Representative may get the required work performed through other ways and means at the risk and cost of the Contractor and the expenditure incurred on obtaining such services shall be deducted from the amounts due from the Employers to the Contactor.
- ❖ No escalation in price whatsoever on any account shall be payable to the Contractor for any item of works and all rates will remain fixed for the total period of the Contract.
- The Employer shall have the right to terminate the Contract wholly or partly by giving a notice of 15 days to the Contractor and to invoke/forfeit the earnest money submitted by the Contract.

Evaluation Criteria:

The bids will be strictly evaluated according to the requirement mentioned above in **Specification**, **Qualification Criteria**, **Validity**, **Earnest Money/Security Deposit** and **General Terms & Conditions**.
