 - Supply of Diesel Generator 20KVA with ATS panel of suitable capacity, alternator and with following given technical specifications:
 - Prime Power:20KVA/16KW
 - Standby Power:22KVA/18KW
 - Frequency:50/60 HZ
 - RPM: 1500
 - Phase/Wire: 3phase 4 wire
 - Voltage: 415/240 V 400/230 V
 - Power factor:0.8 Lagging
 - Governing Type: electronic
 - Cooling Method: Water
 - Cycle: 4stroke
 - Exciter Type: Self Excited
 - Insulation Type: Class H
 - Controlling System: Electronic Module
 - Engine Make: Perkins, Cummins, Johns Deere or equivalent

- b) Installation, testing and commissioning of 20 kVA DG set with proper control cables, earthing and foundation arrangements as per complete specs. The selected bidder shall provide 01-year warranty/services/hardware parts replacement and software support free of cost. The bidder shall ensure that all equipment and its parts are new and free from any sort of defects.
